The rate of pay will be \$37,028.00 less 4% concession (Step 1 of the BA Salary Schedule) There were four applicants for this position and all four were interviewed. Motion carried unanimously.
- #9 TEACHER - Motion by Mr. Manning, support by Ms. Murray that the Board approve Rachel Elson as a Teacher at Parker Elementary, effective August 30, 2017, contingent upon approved physical, records check and fingerprints. The rate of pay will be \$37,028.00 less 4% concession (Step 1 of the BA Schedule). There were forty applicants for this position and twenty were interviewed. Motion carried 4-2. Ms. Lewis-Moss and Shenique Moss voting no.
- #10 TEACHER - Motion by Mr. Scott, support by Ms. Murray that the Board approve Christine Davey as a Teacher at Parker Elementary School, effective August 30, 2017, contingent upon approved physical, records check and fingerprints. The rate of pay will be \$43,566.00 less 4% concession (Step 4 of the BA Schedule). There were forty applicants for this position and twenty were interviewed. Motion carried 4-2. Ms. Lewis-Moss and Shenique Moss voting no.
- #11 TEACHER - Motion by Ms. Murray, support by Mr. Scott that the Board approve Lisa-Marie James as a Teacher at McGlennen Elementary, effective August 30, 2017, contingent upon approved physical, records check and fingerprints. The rate of pay will be \$37,028.00 less 4% concession. (Step 1 of the BA Salary Schedule). There were forty applicants for this position and twenty were interviewed. Motion carried 5-1. Ms. Lewis-Moss voting no.
- #12 CHROMEBOOKS - Motion by Ms. Murray, support by Shenique Moss that the Board approve the purchase of 40 HP Chromebooks and licenses from CDW-G for a total cost of \$8,359.60 for the High School/Middle School Coding Classes. Motion carried unanimously.

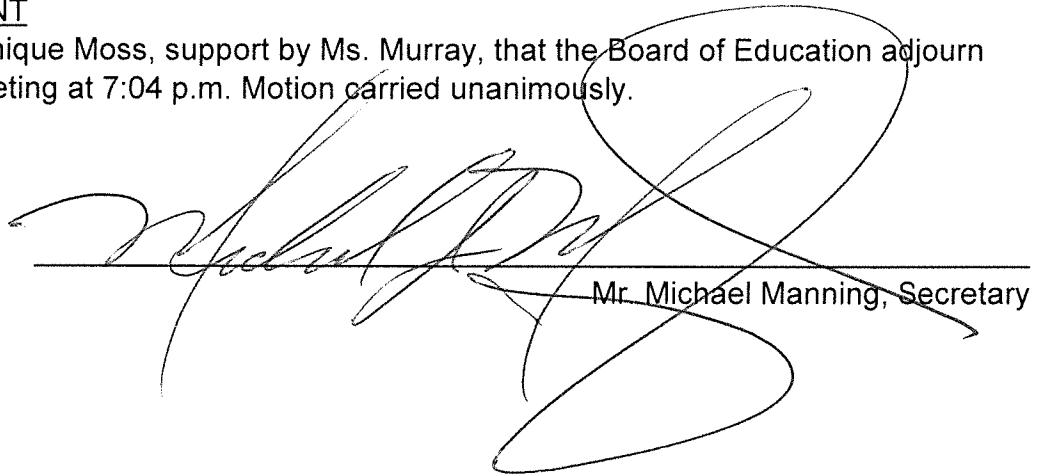
